About the Seattle Ethics and Elections Commission

The Commission is a seven-member, citizen body that interprets, administers and enforces the Seattle Elections Code, Ethics Code, Election Pamphlet Code and Whistleblower Protection Code. Three members are appointed by the Mayor; three are appointed by the City Council and the seventh is appointed by the other six. All seven are confirmed by the City Council. The term of office for a commissioner is three years.

Biennial Report on Election Financing

The SEEC, following the biennial elections for municipal officeholders, publishes a report showing the money raised and spent promoting or opposing candidates and ballot issues.

Charts showing the contributions to, and expenditures by, candidate and ballot issue committees are also available on the Commission's web site: www.seattle.gov/elections. Visitors to the web site can access to up-to-date figures on:

- > Total Contributions (in Dollars) and Total number of Contributors to each and every campaign committee, together with charts breaking down the data by the
 - **→** Contributor type (individual, business, PAC, etc.)
 - + Contribution size (\$25 and under, \$100 \$399, \$400 -\$599, etc.)
 - **→** Contribution area (broken down by Seattle neighborhood);
- Total Expenditures made by each and every campaign committee, including Independent Expenditures with breakdowns on what each campaign spent funds on (Literature and mail, fundraising, advertising, etc.).

Visitors to the web site can also get a list of every contributor of more than \$25 to every campaign, and can search the Commission's database by name, or by employer.

This report does not include all of the charts and graphs already available on the web site. Instead, this report provides some information placing the financing of the 2013 election season in historical context, and provides some information that is not readily accessible at our web site.

This report covers all disclosed activity from the beginning of the 2013 election cycle through December 12, 2013.

Summary of 2013 Contributions

Tables 1 and 2 on the following pages list the total amount of contributions received by each person who registered their candidacy with the Commission, and ballot issue committee organized into three categories:

- > contributions and loans from the candidate;
- > miscellaneous receipts, such as proceeds from t-shirt sales or transfers from a previous committee for the same office;
- > contributions from individuals (excluding the candidate) and groups.

The tables also detail the number of contributors, other than the candidate, to each campaign and the average size of the contribution from those contributors.



The 2013 City Council Contests in Context

1. The number of small contributions to City Council campaigns rose sharply while larger contributions declined.

For the first time in ten years, the number of low-dollar contributors exceeded the number of higher dollar contributors. While the total number of contributors to council candidates increased slightly from 2011, the number of contributors making contributions of under \$100 almost doubled.


Contributors in the mid-range (\$100-\$599) were down by 33% since the 2011 election cycle. Contributors at the high-range (over \$600) were down 43%.



¹ This number factors out individual contributors who made more than one contribution to a single campaign, but counts as two contributors one individual who gave to two campaigns, as three contributors one individual who gave to three campaigns, and so on.


2. Percentage of low-dollar contributors surpasses mid- and high-range contributors.

For the past three election cycles, the number of mid-range contributors (\$100-\$599) has outnumbered low-dollar contributors (under \$100). In 2013, low-dollar contributors mid- and high-dollar contributors combined.




3. The average value of contributions to City Council campaigns fell sharply in 2013.

The average value of contributions to City Council campaigns dropped from \$231 in 2011 to just \$136 in 2013, a 40% drop.




4. Total Council Campaign Fundraising.

The total dollars contributed to Council campaigns was significantly lower than usual.



5. Money spent on literature and mail continued to rise, and money spent on fundraising fell by half.

Literature and mail were still the spending priority for council candidates. Money spent on other ads, presumably on-line advertising, continued to rise steadily.




The 2013 Mayoral race in context

In 2013, six candidates for Mayor raised more than \$200,000, making this the most expensive mayor's race in years.


For the first time since 2001, the number of contributors to mayoral candidates (9,257) exceeded the number of contributors to Council candidates (6,707).

6. Number of Contributions by Contribution Size




7. Contributions by Size as a percentage of total contributions

For the second cycle in a row, low-dollar contributions (under \$100) made up a third of all contributions raised in the Mayoral race. Prior to 2009, half of all contributions to the Mayor's race were at the under \$100 level.




8. Average Contribution Size

The average contribution remained virtually constant, dipping slightly from \$237 in 2009 to \$235 in 2013.




9. Contributions by size

The funds raised in contributions of more than \$600 exceeded \$1 million for the first time.





11. Expenditures by type



Independent Expenditures

Independent spending on the mayor's race almost quadrupled between 2009 and 2013, rising from \$153,703 to \$567,081. Independent spending on Council races totaled only \$3,577 in 2013.





The Council ends transfers between campaigns.

In 2012, the Council enacted legislation To bar candidates from carrying over campaign funds from one election cycle to the next. There was a transition period in 2012 when candidates had the option of rolling funds from their prior campaign over to the new campaign. Most candidates opted to dispose of their surplus in other ways.
