ABOUT THE SEATTLE ETHICS AND ELECTIONS COMMISSION

The Commission is a seven-member, citizen body that interprets, administers and enforces the Seattle Elections Code, Ethics Code, Election Pamphlet Code and Whistleblower Protection Code. Three members are appointed by the Mayor (confirmed by the City Council), three are appointed by the City Council and the seventh is appointed by the other six and confirmed by the City Council. Members serve three year terms.

BIENNIAL REPORT ON ELECTION FINANCING

Pursuant to SMC 2.04.060.H, this office, following the biennial elections for municipal officeholders, publishes a report "setting forth, as to each committee promoting or opposing a candidate or ballot issue on the ballot that year, the amounts and sources of all contributions and the amounts and purposes of all expenditures received by or made by those committees."

Regularly updated figures showing the contributions to, and expenditures by, candidate and ballot issue committees are available on the Commission's web site:

www.seattle.gov/elections. By clicking on "Charts & Graphs" on the menu and selecting the 2007 election, a visitor to the web site has access to up-to-date figures on:

- the total dollar value of contributions to each and every campaign committee, together with charts breaking down the data by the type of contributor, the size of the contribution, and the area from which the contribution was reported;
- thee total number of contributors to each and every campaign committee, together with charts breaking down the data by the type of contributor, the size of the contribution, and the area from which the contribution was reported;
 - the total value of expenditures made by each and every campaign committee;

Visitors to the web site can also get a list of every contributor to every campaign, and can search the Commission's database by name – for example, "John Doe" – or by employer – for example, "City of Seattle."

This year we are not reproducing the charts and graphs already available on the web site. Past reports have run approximately 50 pages, so printing even ten copies of the report involves a ream of paper. Instead, in this report we'll provide some information placing the financing of the 2007 election season in historical context, and provide some information that isn't readily accessible at our web site.

The information in this report was compiled from the disclosure filings of each candidate and ballot issue committee. The report covers all disclosed activity from the beginning of the 2007 election cycle, May 1, 2004, through February 20, 2008.

A. Summary of All 2007 contributions

Tables 1 and 2 below list the total amount of contributions received by each candidate and ballot issue committee from four categories: 1) contributions and loans from the candidate; 2) miscellaneous receipts, such as proceeds from t-shirt sales or transfers from a previous committee for the same office; 3) uncoded receipts, which are small contributions of \$25 or less and are not itemized by campaigns; and 4) contributions from individuals and groups. This chart also details the number of contributors, other than the candidate, to each campaign and the average size of the contribution from those contributors.

B. The 2007 Election in Context

1. The number of contributors to City Council campaigns declined.

As of this writing, 7,604 contributors¹ participated in the 2007 City Council election, the lowest number since 2001, when just 5,122 contributors gave to City Council candidates, and the second lowest total since the 1997 election cycle. There were a total of 11,687 contributors in 2003, and 10,090 in 2005.

The number of contributors who gave less than \$100 was at its lowest level since the Commission began tracking contributions by size. 2,766 contributors gave less than \$100, compared to 3,227 in 2001, 6,277 in 2003 and 4,632 in 2005.



¹ This number factors out individual contributors who made more than one contribution to a single campaign, but counts as two contributors one individual who gave to two or more campaigns.

2. The average value of contributions to City Council campaigns continued to increase.

As **Figure 2** below shows, the rate of increase in the average contribution has accelerated since 2001. For 2007, the average contribution totaled \$213, almost doubling in three election cycles.² The average contribution increased by 24 percent between 2001 and 2003, 19 percent between 2003 and 2005, and 25 percent between 2005 and 2007. In contrast, it increased by just five percent between 1993 and 1995, seven percent between 1995 and 1997, 14 percent between 1997 and 1999, and seven percent between 1999 and 2001.



² The average contribution size excludes contributions from candidates, so it is not skewed by candidates who spent large sums of money on their own campaigns.

3. Campaigns raised the same amount of money as they had raised in the past, but from fewer donors.

As **Figure 3** below shows, City Council campaigns have been able to raise roughly the same amount of money, despite the drop in the number of contributors. Note that in 2003 and 2005 the campaign contribution limit was \$650, and in 2007 it was \$700.



4. Spending money to get money

There is one notable development in the data that we collect on expenditures and it is intertwined with the developments in contribution patterns discussed above. As **Figure 4** below shows, the amount of money that City Council campaigns spent on fundraising in 2007 was more than double what they spent in 2005, and significantly more than they spent in 2003. In 2007, campaigns spent on fundraising almost 11 cents of every dollar they raised.



3. Independent Expenditures Supporting or Opposing City Council Candidates

Independent spending in the 2007 election cycle was roughly double what it was in 2005, with the figure rising from \$50,437 to \$101,115. In 2003, independent expenditures totaled just \$20,504.

The 2007 election cycle marks not the advent of six-figure independent expenditure efforts, but a return to form. In 1999 and 2001, respectively, independent expenditures totaled \$113,321 and \$106,623.

4. **Candidate Contributions**

Thus far in this election cycle, candidates have contributed \$183,074 to support their own campaigns. If committees were to forgive outstanding loans to the candidates as of this writing, and in our experience many do, the total would rise to \$211,510. By comparison, candidates spent \$253,389 of their own money in the 2003 election cycle, and \$91,601 in 2005.
