An agency does not need a physical address in the city of Seattle to be eligible to apply.
5	Eligibility	My Food Bank has a budget in the neighborhood of \$300,000. It is also part of the Senior Center & Food Bank which has a budget in excess of the \$750,000 eligibility cap. The Senior Center and the Food Bank have one EIN, one board, and one administrative structure but operate from separate locations serving mostly-distinct populations.  How would the budgetary/operational distinction be considered by HSD/YFE for this RFP?	Even though the organization has a service area with an operating budget of \$300,000, the service area is still part of the larger organization with an operating budget of more than \$750,000, which makes the organization ineligible to apply for this RFP.
