<b>COVID-19 Gig Worker Premium Pay Ordinance Fact Sheet</b>	<b>Xeerka Xaashida Xaqiiqda ee tilmaamaya bixinta mushahaar sare oo uu helo iskiis u shaqeyste</b>
The Gig Worker Premium Pay Ordinance requires covered Food Delivery Network Companies to pay gig workers additional compensation, called “premium pay,” for delivery orders with pick-up or drop-off points in Seattle. Premium pay is in addition to compensation, bonuses, commissions, and tips owed to a gig worker for services provided. This law is effective from 8:30 PM on June 26, 2020 until the end of the COVID-19 civil emergency.	Xeerka Bixinta Mushahaarka Sare waa mid laga doonayo Shabakadaha Shirkadaha Cunto geynta inay dadka iskood u shaqeysta siyaan mushuhhaar deeraad ah oo la yiraahdo “Mushahar Sare” mar haddii ay geynayaan dalabyada qaadista amase geynta nawaaxiga Seattle. Mushahaarka sare waa ka dheeraad magdhowga, gunada iyo abaal-marinta ay leeyihiin dadka xoogsada ah taasoo ku aadan adeegyada ay bixiyaan. Sharcigan waxa uu hirgaleyaa laga bilaabo 8:30 PM ee June, 26th, 2020 ilaa dhamaadka Covid 19 xaaladiisa degdega ah.
<b>Which companies are covered by this law?</b> This law applies to Food Delivery Network Companies (FDNCs), which include companies that offer prearranged food, beverage, or grocery delivery services for compensation using an online or cellphone application to connect customers with delivery workers (“gig workers”). To be covered by this law, the FDNC must hire 250 or more gig workers worldwide.	<b>Shirkadahee buu sharcigani qabanayaa?</b> Sharcigani waxuu qabanayaa shirkadaha ku mideysan cunta geynta (FDNCs) kuwaasoo ay ku jiraan shirkadaha bixiya sii dalbadashada cuntada, cabitaanka, amase adeega geynta raashinka (grocery) oo bixiya mushahaarka adoo isticmaalaya internetka amase taleefankaa taasoo macaamiisha ku xiraya shaqaalaha wax geeya (Gig Workers). Si sharcigani u hirgalo, the FDNC waa inay shaqaaliisaa dad iskood xoogsata ah oo badan caalamkoo dhan.
<b>Which gig workers are covered by this law?</b> This law applies to gig workers who accept offers of delivery services for compensation from a covered FDNC. To be covered by this law, the gig worker must make a delivery with a drop-off or pick-up point in Seattle.	<b>Waa kuwee xoogsatada uu sharcigani daboolayo?</b> Sharcigani waxuu daboolayaa dadka xamaalatada oo aqbala bixinta adeega wax geynta si ay u helaan mushahaar/magdhow shirkadaha oo saameyey FDNC. Si uu sharcigani u dhaqan galoo, qofka xoogsadeha ah waa inuu sameeyaa adeega geynta sida qaadis amase geynta goob ka mida Seattle.

<p><b>How much premium pay is owed?</b>  A gig worker must receive at least \$2.50 per order in premium pay, where there is either a pick-up or drop-off in Seattle.</p> <p>A worker is also owed the following additional amounts if applicable to that same online order:</p> <ul style="list-style-type: none"> <li>▪ \$1.25 for each additional pick-up point in Seattle</li> <li>▪ \$1.25 for each additional drop-off point in Seattle</li> </ul>	<p><b>Imisaa mushahaar dheeraada bey leeyihii?</b>  Qofka xoogsade ah waa inuu helaa ugu yeraan \$2.50 dalabkasta oo bixin/mushuhhaar dheeraada, meeshaas oo qaadis amase geedis ay jirto oo Seattle ah.</p> <p>Qofkasta xoogsade ah waxuu xaq u leeyahay qaybo dheeraada hadii tahay dalab internetka oo kale.</p> <ul style="list-style-type: none"> <li>• \$1.25 dalab kasta oo dheeraada oo laga qaado Seattle</li> <li>• \$1.25 dalab kastoo oo la geeyo meel Seattle ah.</li> </ul>
<p><b>Food Delivery Network Companies must:</b></p> <ul style="list-style-type: none"> <li>▪ Pay premium pay at the same time compensation is provided for the rest of the online order</li> <li>▪ Identify which orders qualified for premium pay</li> <li>▪ Separately itemize premium pay from other compensation</li> <li>▪ Provide workers with individual, written notice of the rights granted by this law, including the right to be free from retaliation.
