Applicant: Hannah Estrich, SKL Architects

Ms. Frestedt explained the proposed change of use from restaurant/cafe to office, for SKL Architects. "Office" is not a preferred use within SMC 23.66.326 – Street-level uses. Therefore, it cannot be reviewed administratively. She said that this use may be appropriate, so long as the transparency requirements of SMC 23.66.336 are met and there is pedestrian activity into/out of the storefront.

Gladys Ly-Au Young, SKL Architects, said they intend to use the space not just for their office but also to build a platform for art, cultural development, and neighborhood transformation, including space provided for community events. She provided a brief history of the Eastern Hotel, one of the earliest buildings in the district, and its early use. She noted the many partner organizations working in the area now.

Hannah Estrich provided proposed layout with gallery, community gathering space and their books and samples on the first floor.

Ms. Frestedt said the building is a contributing building in the district, as well as an individual designated city landmark.

Mr. Lam said the proposed use is not a preferred use, under SMC 23.66, but he commended the applicant for inclusion of additional program of gallery space.

Action: I move that the International Special Review District Board recommend approval of a Certificate of Approval for use, per the submitted application materials.

The Board directs staff to prepare a written recommendation of approval, based on considering the application submittal and Board discussion at the April 23, 2024, public meeting, and forward this written recommendation to the Department of Neighborhoods Director.
