Description of proposal: The Seattle Department of Transportation (SDOT) proposes pavement repair and replacement, including full depth reconstruction, mill and overlay with base repair, and concrete panel replacement on SW Avalon Way and 35th Ave SW in West Seattle. Seattle Public Utilities will also replace a water main under 35th Ave SW between SW Avalon Way and SW Snoqualmie St. Other improvements include Americans with Disabilities Act (ADA)-compliant curb ramps, sidewalk and curb and gutter construction, pedestrian crossing improvements, and compliance with the Seattle Stormwater Code. Pipes and inlets would be installed for most new curb ramps as part of drainage improvements. An estimated one temporary construction easement would be required for the project.
